# AMD GAMEON 2025 SWEEPSTAKES OFFICIAL RULES AND TERMS

1. <u>5. How to Enter:</u> During the Entry Period, Participants will need to visit the official AMD GameOn 2025 website (<a href="www.amdgameon.in">www.amdgameon.in</a>) and register as 'visitors'. Registering as a visitor is free but is subject to the applicable terms of service. To earn one (1) entry into the Sweepstakes ("Entry"), Participant must:

- 1. Participants need to come the AMD GameOn event at Indiajoy Hyderabad, HICC and collect the entry pass, by showing their QR code they have received upon registration.
